A Donor Advised Fund (DAF) is a charitable giving vehicle that allows donors to contribute funds, receive an immediate tax benefit, and recommend grants to their favorite nonprofit organizations over time. This guide outlines the steps to support Clayton Youth Enrichment through your DAF.

Steps to Donate to Clayton Youth Enrichment via Your DAF

1. Contact Your Fund Administrator

Reach out to the financial institution or community foundation that manages your DAF. Most providers offer online portals or forms to recommend grants.

3. Grant Purpose (Optional)

If desired, designate your grant for a specific purpose, such as:

- General Operating Support
- Clayton After-School Programs
- Special Fundraising Campaigns (e.g., capital projects, technology upgrades, event sponsorships, scholarships and discounts for families, etc.)

4. Submit Your Grant Recommendation

Follow your DAF administrator's procedures to submit your grant recommendation. If additional information is needed, they may contact you or Clayton Youth Enrichment directly.

Important Details To Note

No Benefits in Exchange for Your Gift

IRS regulations prohibit donors from receiving personal benefits in exchange for DAF contributions. This includes event tickets, auction items, and other goods or services. Contributions must be strictly charitable.

Acknowledgment of Gifts

While gifts from DAFs do not typically qualify for an additional personal tax deduction, Clayton Youth Enrichment will recognize your generosity with a formal thank-you.

Grant Recommendations

Donors can recommend multiple grants over time. You may make a one-time gift or set up recurring grants to support Clayton Youth Enrichment's ongoing programs and initiatives. For guidance on grant recommendations, contact our Advancement Team at <u>ccc@claytonyouth.org</u>.
